Project description *

Rural communities in the hinterland of Suriname have benefited from Australian DAP program interventions with low-cost rainwater harvesting systems and sanitation to address the issue of poor access to potable water. Incidentally, rural schools that serve the villages suffer a similar fate of relying on contaminated riverine water with mercury, high levels of turbidity effects of gold mining, logging and absence of proper sanitation facilities, forcing school children to utilize these water sources. The Rooms Katholiek Byzonder Onderwijs Foundation, manages seventy-six primary and secondary schools in Suriname, many of them in the hinterland of Suriname serving these isolated villages. The Foundation is desirous of seeking support to establish rainwater harvesting systems in three (3) of its primary schools located along the Upper Suriname River in the Hinterland of Suriname. The project seeks to install a low-cost PVC rainwater harvesting system for three (3) primary schools in the District of Sipaliwini.

Why does this work need to be done? *

This work is required because many primary school children in the hinterland of Suriname are facing serious health risks by consuming mercury contaminated water. In some indigenous villages, some residents have been tested with several times the minimum acceptable levels of mercury in the body tissue due to consumption of contaminated and water consumption form riverine sources. Indiscriminate and illegal harvesting of timber also leading to erosion and high turbidity in riverine sources. This situation is compounded with the more frequent and intense droughts which are being experienced due to climate change. Many of these primary schools are lacking of rainwater harvesting systems. Public sector resources are scarce and the hinterland is not an area prioritized for public spending so public utility infrastructure remains poor. The geographic isolation of these primary schools, means that with inadequate storage facilities for rainwater, they are forced to consume unhealthy water. The high rainfall climate of Suriname means that with adequate storage, some measure of relief and protection can be brought to affected primary schools. What are the planned activities? *

The planned activities are: 1. Procurement of supplies; Transportation of materials to the primary schools (terrestrial and riverine) Installation of Rainwater systems; Community engagement; Project visibility; Project Monitoring; Project Logistics/Management; handover ceremony; Report preparation and submission; Briefly list (Bullet Points) the specific activities that will take place and where they will take place (200 words recommended)

What are the expected outcomes of the project?

- 3 rainwater harvesting systems with a total capacity of 4000 gallons each installed at three (3) primary schools in the hinterland of Suriname by end of the project.

Access to these primary schools can be challenging especially during the dry season. This leads to low water levels in the rivers which affect delivery by boats. The remoteness requires the use of rivers and participants have to be protected from potential water accidents. Efforts will be made to execute during the rainy season. Protective gear is available for persons engaged in implementation to reduce potential physical injury. The installation of the water harvesting system at the beneficiary primary schools must be managed with local village leaders to ensure that the installation of the systems meets the project criteria.
