I. Background Information

The Inter-American Board of Agriculture (IABA), at its Twentieth Regular Meeting, in October 2019, resolved in Resolution IICA/JIA/Res. 529 (XX-O/19), to request that the Director General:

- 1. Strengthen IICA's coordination of efforts with other public and international organizations, donors, and other strategic partners engaged in agricultural development and the improvement of rural life in small developing States and low-lying developing countries.
- Develop and discuss with those strategic partners a proposal for a coordinated approach to
 effectively address the sectoral challenges and opportunities for agricultural development
 and the improvement of rural life in small developing States and low-lying developing
 countries.
- 3. Present a report to the next Regular Meeting of the Executive Committee on progress in developing and discussing that proposal with the pertinent strategic partners, together with the corresponding recommendations. These recommendations may include, among others, the convening of a meeting of the strategic partners for the purpose of reaching the necessary agreements.

As such, IICA presents to the Executive Committee the actions that have been undertaken in the year 2020 and the first quarter of 2021 to accomplish the requests addressed to the Director General in Resolution IICA/JIA/Res. 529 (XX-O/19).

Agreements with Key Regional Integration Bodies

IICA has active working agreements with the two main Regional Integration Bodies in the Caribbean Region.

The Memorandum of Understanding between IICA and the Organisation of the Eastern Caribbean States (OECS) was signed on July 17th, 2018, and is due on July 17th, 2021; currently, discussions are going with the OECS Commission for the renewal of the agreement.

The IICA-CARICOM General Technical Cooperation Agreement was signed on August 5th, 2019, and is due to execution until August 4th, 2022. This agreement covers actions aimed at contributing as effectively as possible to agricultural development in any country in Latin America and the Caribbean in which both institutions have common areas of interest, to accelerate the improvement of agriculture and rural development.

II. Strategic Alliances 2020-2021

Among others, IICA has in place the Memorandum of Understanding with the Organisation of the Eastern Caribbean States and the IICA-CARICOM General Technical Cooperation Agreement. A detailed list of IICA's strategic alliances is the following:
