## TECHNICAL COOPERATION BY THE GOVERNMENT OF JAPAN

## PROPOSAL

By the Inter-American Institute for Cooperation on Agriculture (IICA) for an expert, i.e., an investment project specialist, to be assigned to the Center for Investment Projects (CEPI) to the Government of Japan.

1. The Center for Investment Projects (CEPI) of IICA, is a technical support unit under the supervision of the Office of the Deputy Director General for Operations. It was established in August 1982.

Its purposes are to cooperate with the Member States and operating units of IICA in the identification, formulation and evaluation of investment projects; provide support in the formulation of IICA's technical cooperation projects; conduct training activities in project formulation, evaluation and management for professionals from IICA member countries; and design of methods for carrying out the above.

CEPI's staff consists of eight university-level professionals: four have Master's degrees, two have doctorates.

Over the past six years, CEPI has drawn up thirteen (13) investment projects for a total of US\$400 million, aimed at promoting development of the agricultural sector in ten Latin American and Caribbean countries (Barbados, Bolivia, Costa Rica, Ecuador, Haiti, Honduras, Jamaica, Panama, Paraguay, Venezuela), within the framework of the technical cooperation agreement IICA has with the Inter-American Development Bank (IDB) for preparing agricultural projects. Most of these projects are in operation, funded with national resources and IDB funds. IICA and IDB anticipate signing a third stage of the agreement in the second semester of 1988, for the amount of US\$3.5 million for preparing projects over the next three years.

CEPI works to identify and prepare investment project profiles in cooperation with its member countries, to be funded by other sources such as the World Bank and the International Fund for Agricultural Development (IFAD). Under an agreement between IICA and IFAD, CEPI participated in 1987 and 1988 in project identification missions in Brazil and Mexico, with funding from IFAD.

As concerns training in agricultural project development at the farm, national and regional levels, CEPI organizes different types of events, courses and seminars in member countries, for national professionals. In 1988 such activities were conducted in Honduras, Costa Rica and Mexico, where a total of 70 technical experts received training.

In the framework of the agreement between IICA and the Iberoamerican Cooperation Institute (ICI), two courses are offered yearly: one on project preparation and evaluation, and another on agricultural project management at ICI's International Development Center in Santa Cruz de la Sierra, Bolivía. Each of the courses is attended by 25 university professionals from the South American countries.
