AUDIT REVIEW COMMITTEE (ARC) NOMINATED CANDIDATES

Ribeirão Preto, São Paulo Brazil Article 3 (j) of the Rules of Procedure of the Executive Committee and Article III of the Statute of the Audit Review Committee ("ARC Statute") stipulate that the Executive Committee is responsible for electing the members of the Audit Review Committee.

Pursuant to the ARC Statute, at least one of the three members of the ARC shall be elected from among the candidates presented by the six Member States that are the largest contributors to IICA, and at least one member shall be elected from among candidates nominated by the other Member States.

The Executive Committee, at its Nineteenth Regular Meeting and in response to an offer from the Government of Mexico, appointed Mr. Luis B. Correa Sanchez as a member of the ARC. Mr. Correa served on the ARC from January 1, 2000, to July 31, 2001. When he left his government position to join the private sector, he was replaced, in accordance with Article III. 3.3, by Mrs. Alma Rosa Zepeda Garcia, who served throughout the rest of 2001 and until September 30, 2002. She was later replaced by Mr. Luis Carlos Gutierrez Jaime, who served until December 31, 2005.

In compliance with the rules currently in effect, in 2005, the Director General asked the Member States to nominate candidates to sit on the ARC from January 2006 to December 2011. The following nominations have been received:
